IDLO's strategic objectives support the realization of the 2030 Agenda for Sustainable Development, driven by Goal 16 on peace, justice and effective institutions.



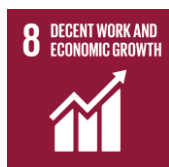
SUSTAINING PEACE IDLO promotes institution-building, legal empowerment and respect for human rights. Operating in fragile, conflict-affected contexts, IDLO contributes to **stabilization and peacebuilding** efforts by addressing the root causes of insecurity.



JUSTICE FOR WOMEN IDLO advances the **human rights of women and girls** through empowerment and institution-building initiatives. Its programs focus on the **elimination of sexual and gender-based violence**, as well as empowering women to access their social and economic rights.



JUDICIAL INDEPENDENCE To advance judicial independence, IDLO works to strengthen the **capacity and integrity** of the judiciary. Its institution-building initiatives promote **transparency, accountability and anti-corruption**, which in turn enhance **public confidence**.



ECONOMIC DEVELOPMENT IDLO promotes sustainable and inclusive development by building capacity for **commercial law, alternative dispute resolution**, economic governance and better management of trade and investment.



INFORMAL JUSTICE IDLO seeks to close the justice gap by strengthening the linkages between customary and informal justice systems and formal institutions and **promote meaningful access to justice**, especially for the most vulnerable and marginalized.



INCLUSION AND EQUALITY Working closely with civil society, IDLO combats **discrimination** and seeks to enhance **social inclusion**. Through legal empowerment strategies, awareness-raising initiatives, and direct **support to community organizations**, IDLO works to ensure women, poor and marginalized groups are empowered to claim their rights.



HEALTH AND FOOD IDLO **strengthens the legal capacity** of countries to promote healthy diets and physical activity for the prevention of non-communicable diseases.

AFGHANISTAN

As part of its decade-long endeavor to advance the **elimination of violence against women and girls**, IDLO supports specialized training sessions with the Attorney General's Office and the Ministry of the Family Response Unit to improve officials' interactions with survivors of gender-based violence.

HONDURAS



To build a culture of peace and justice, IDLO supported the adoption of alternative dispute resolution mechanisms and helped to develop a national roadmap for **restorative justice** within the criminal justice system.

INDONESIA

IDLO supported partner organizations to train paralegals to provide legal advice to people who live on vast peat lands so that they are able to **protect their land rights** against threats from resource extraction and agribusinesses.

LIBERIA

To combat **trafficking in persons**, IDLO continued to build the capacity of law enforcement to effectively investigate cases, as well as facilitate awareness raising activities targeting both communities and law enforcement officials.

MONGOLIA

IDLO works to identify the obstacles faced by survivors of **domestic violence** in accessing justice, strengthens access to legal aid and services, and empowers them to claim their rights.



MYANMAR



Increasing **public legal awareness** of the rule of law and human rights remains a key focus of the Rule of Law Centres which have reached 20,000 citizens across the country since 2015.

TUNISIA

A new project strengthens justice mechanisms and awareness raising at the local level to **empower women to access legal services** for sexual and gender-based violence and claim their socio-economic rights.

UGANDA

IDLO is launching a new program that works with state and non-state actors to enhance **access to justice** through accessible, quality and sustainable justice services at the national, district and community levels.



NEW INITIATIVE To address the **legal needs of women and girls**, IDLO, in cooperation with UN Women, is developing a new project in Sierra Leone, the Philippines and Kenya to analyze and support the elimination of discriminatory laws and policies, working with national stakeholders to make gender equality a lived reality.

AFGHANISTAN

Building on past programs to strengthen justice sector institutions, IDLO launched a new project that aims to explore and develop innovative solutions to **ameliorate the impact of insecurity** on justice professionals, institutional capacity development and women's meaningful participation in the justice sector.

KENYA

IDLO promoted the reduction of case backlog through support to the **Court Annexed Mediation process**, an alternative dispute resolution mechanism aimed at removing some of the burden currently put on the courts.



MEXICO



Under a country-wide program to **build the capacity of the security sector**, over 1,000 police officers underwent IDLO's Training of Trainers courses at the municipal and state levels, rendering a multiplier effect to improve the criminal justice process.

MOLDOVA

To stimulate economic growth, IDLO's project promotes and facilitates the use of **commercial mediation** on a national scale, with the goal of making alternative dispute resolution methods a business norm in the country.



PHILIPPINES

Supporting justice institutions to improve their prosecutorial mandate, IDLO partnered with the Anti-Money Laundering Council and enhanced its capacity to effectively deal with cases **combatting illicit funds** and money laundering.

SOMALIA

As part of a range of institution-building initiatives, with IDLO's support, Somalia finalized several national policies to provide rights-based durable solutions for the **return, reintegration and protection** of internally displaced persons and refugees.

UKRAINE



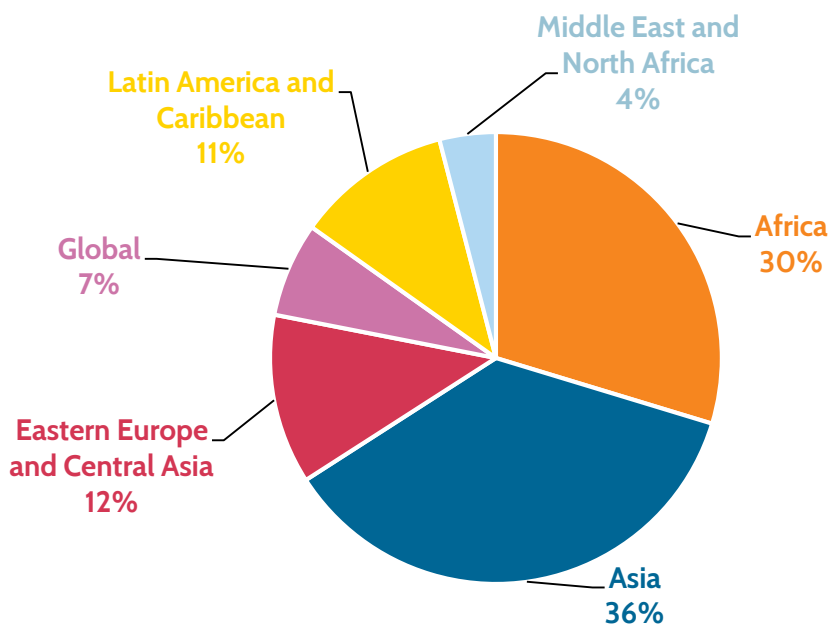
IDLO supported the establishment of the **High Anti-Corruption Court**, the first specialized court of its kind, as part of its broader work to build the integrity of institutions and public trust in the country's anti-corruption efforts.

NEW INITIATIVE IDLO is launching a multi-sector program across countries in the Sahel region to **strengthen the criminal justice chain** and support wide-reaching efforts towards peacebuilding through consultations with local justice actors, building on the model implemented in Mali.

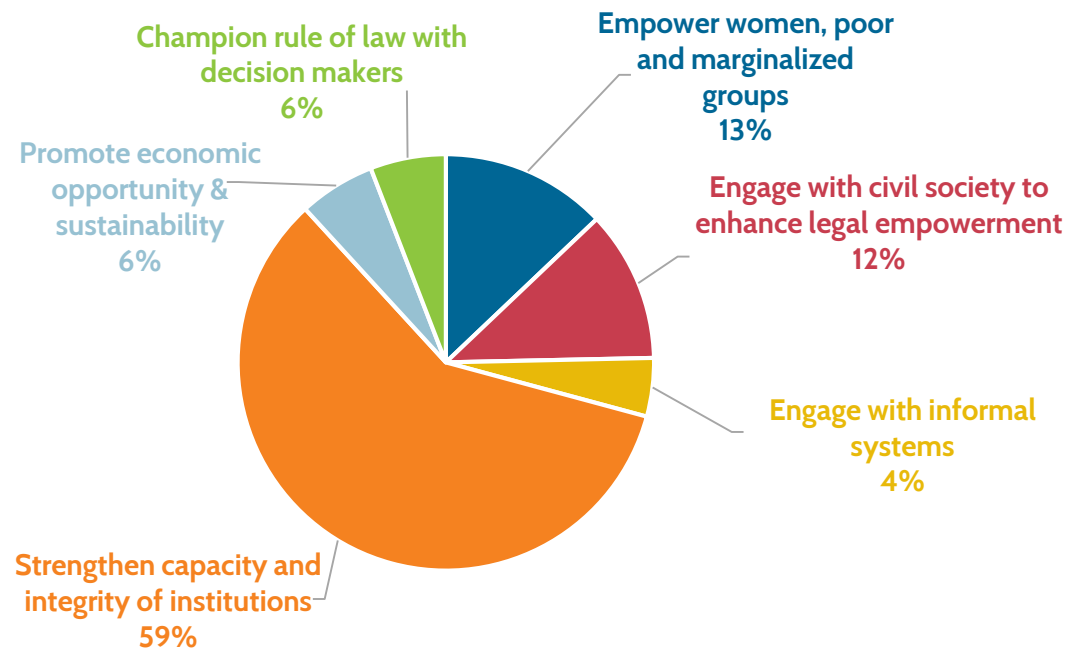
IDLO in 2019

Geographic distribution of IDLO's programs



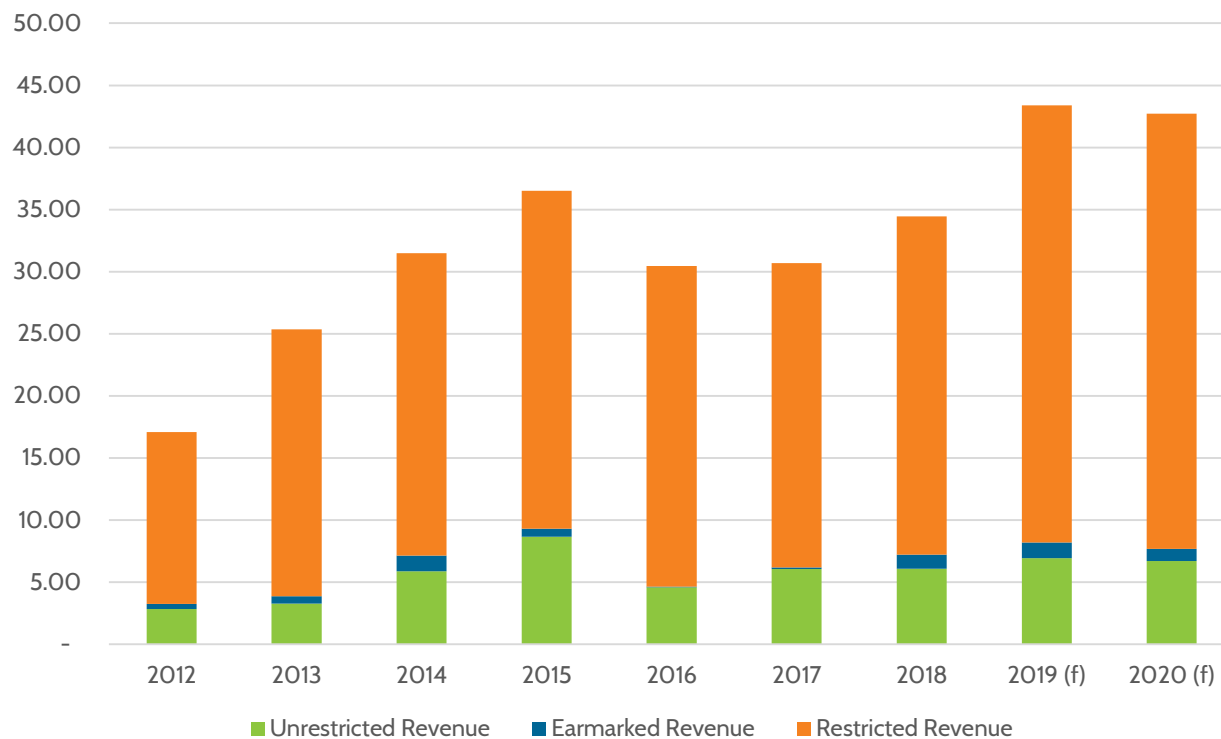
2019 Thematic areas of IDLO's work
